1. The Chairman, Department Consultant Procurement Committee, on behalf of Mahaweli Authority of Sri Lanka invites eligible consulting firms to indicate their interest in providing the above consultancy services.
2. The Mahaweli Authority of Sri Lanka (MASL), is seeking qualified and experienced consultancy firms to express their interest in undertaking consultancy services for the preparation of an Initial Environmental Examination (IEE) Report and/or Environmental Impact Assessment (EIA) Reports for the proposed **Rehabilitation and Agriculture Development Projects in Mahaweli System L and Rambakanoya.**
3. The purpose of the IEE/EIA studies are to assess the potential environmental and social impacts of the proposed project in compliance with the provisions of the **National Environmental Act No. 47 of 1980** (as amended) and the guidelines set forth by the **Central Environmental Authority (CEA)** of Sri Lanka. The study must be conducted in accordance with TOR issued by **Central Environmental Authority and Forest Conservation Department (FCD)**, which have been prepared according to the national EIA and IEE regulations, and should also take into account international best practices where applicable.
4. The consultancy firm will be responsible for conducting a comprehensive IEE and/or EIA study, which includes baseline data collection, impact assessment, stakeholder consultations, and the development of an Environmental Management Plan (EMP). The final IEE and/or EIA reports shall be submitted to the MASL for onward submission to the CEA and FCD for review and approval.
5. Interested and eligible consultancy firms with demonstrated experience in preparing EIA and IEE reports for similar development projects are invited to submit their Expressions of Interest including following information;
 - (i). Ownership of the firm
 - (ii). List of similar development assignments carried out for past 05 years.
 - (iii). Name and short CVs of Key staff officers of the firm
 - (iv). Audited financial statement for last 03 years.

6. Consultant will be selected in accordance with the procedures set out in the Guidelines for Selection and Employment of Consultants, published by National Procurement Agency 2007 following Quality and Cost Based Selection method (QCBS).
7. Interested firms should provide necessary details/information as requested above with **01 original and 05 copies** for shortlisting along with the EOI.
