Bidders, who have the Grade and field of registration under the CIDA scheme of registration mentioned in the above table against the work and in the case of the contract value is above Rs.5Mn. registered in the Department of the Registrar of companies under the provision of public contract Act No.3 of 1987 only will be eligible for bidding. World Bank Procurement Guidelines and Procurement Regulations for IPF Borrowers – July 2016 Revised November 2017 and August 2018 shall also be applicable.
