Instructions

The suppliers who are willing to newly register to the MASL supplier registry and if the year 2026 registered suppliers want to apply for extra goods and supplies, shall follow the below steps.

01. The Institutions/Individuals should register for interested each items separately.
02. The application can be downloaded the web site: www.mahaweli.gov.lk of Mahaweli Authority of Sri Lanka. The suppliers shall submit only one Application Form and one payment slip for all the items. The payment for **each item** is **Rs. 1000.00** and the receipt upon payment to the MASL Head Office **Account No. 2327542** of Bank of Ceylon (BOC), Hyde Park branch shall be collected. The supplier's name and **"Suppliers Registration for Year 2026. Mahaweli Authority of Sri Lanka"** wordings shall be mentioned in the cash receipt) **"Receipts and applications will not be issued by the Head Office or by any Mahaweli offices."**
03. The **duly completed application** with the original of **Cash Receipt** and the **Business Registration Certificate** shall be register posted to the address, **Director General, 9th Floor, Procurement Division, Mahaweli Authority of Sri Lanka, No.500, T.B. Jayah Mawatha, Colombo 10** or drop to the tender box available at the same place, to receive on or **before 2.00 p.m on 29.12.2025**. In addition, the caption **"Registration of Suppliers for Year 2026"** shall be written on the top left-hand corner of the envelope containing the application.

Conditions:

01. Applications submitted with incomplete information will be rejected. Qualified Suppliers will be registered after confirming the information submitted.
02. The Mahaweli Authority reserves sole rights to obtain Goods/ Services apart from Registered Suppliers list whenever required even though the quotations for Good and services are invited generally from list of registered Suppliers.
03. The below suppliers/ Institutions will be eliminated from the *list of registered suppliers* without prior notice
 - i. Not satisfying the eligibility requirement after the official inspections,
 - ii. Not submit quotations when requested
 - iii. Fail to supply goods and services on time or in accordance with the required standards
04. All the Suppliers should agree to a **minimum of 30-days** credit period
05. Suppliers should have been registered as a businessman for the supply of relevant goods and services.

Important: -

Mahaweli Authority of Sri Lanka will invite the suppliers for Goods and Service through the Promise.lk software under e- Government Procurement. The selection of suppliers under the e Procurement platform will be done only from those registered both in Mahaweli Authority and registered with Promise.lk. Therefore, all suppliers are advised to join the e Government Procurement network through Promise.lk
